January 1, 2025 – New Self-Payment Rates

Dear Participants:

This is an important notice about changes to the Fund's Self-Payment rates, effective January 1, 2025.

These January 1, 2025 changes include *new* Active, Medicare Retiree, Early Retiree, Medicare Split Contract, Surviving Spouse, Disabled Participant and COBRA Self-Payment rates.

SELF-PAYMENT RATES

Q: What are the new Active Self-Payment rates?

A; On January 1, 2025, the current Active Self-Payment rates will increase to the following:
